








DPS&C - CORRECTIONS SERVICES

 FY 2024-2025 Per Act 4



FY 2024-2025 Per Act 4




DPS&C - CORRECTIONS SERVICES

 FY 2024-2025 Per Act 4








Video Court


Percentage of Offenders Diagnosed with SUD on Programming Waitlist






Mental Health Level of Care Region 1 - By Average Population




Total Referrals to Community Resources by Quarter By Releases








Total Individuals Who Refused Programming by Quarter




Ashland Enrollment - Pell Experimental Study

TONY MARABELLA, Vice Chairman Pardon & Parole




Brennan C. Kelsey, Parole

Qualifications & Training

As mandated in LARS 15:572.1, Board Members must have a bachelor's degree and at least five years of experience in the field of penology, corrections, law enforcement, sociology, law, education, social work, medicine, psychology or psychiatry, or a combination thereof. If the member does not have at least a bachelor's degree, he or she must have no less than seven years of experience in one of the aforementioned fields.

After their appointment, Board Members are required to participate in at least 40 hours of continuing education as part of our American Correctional Association (ACA) Accreditation. Our team works diligently to provide training opportunities for Board Members and Staff. The Department of Public Safety & Corrections (DPS&C) and the population they serve are often at the center of these training events (pictured from left is Chairman Ranatza, DPS&C Secretary James LeBlanc, and Vice Chairman Marabella). We are constantly searching for emerging trends and the latest research as it relates to public safety and our work as the discretionary releasing authority for the State of Louisiana.

Clemency Process

The Governor may grant reprieves to persons convicted of offenses against the state, and upon recommendation of the Board of Pardons, may commute sentences, pardon those convicted of offenses against the state, and remit fines and forfeitures imposed for such offenses.

Notwithstanding any other provision of law to the contrary, the governor shall not grant any pardon to any person unless that person has paid all of the court costs or fees imposed in connection with the conviction of the crime for which the pardon is to be issued.



APPLICATION – Applications are submitted. Incarcerated individuals submit programs of completion, disciplinary conduct, and reentry plan. Released individuals submit current employment status and reason for request.

ADMINISTRATIVE REVIEW – Application is granted (hearing scheduled) or denied.


INVESTIGATION – Investigation is ordered. Victims are interviewed by Victim Assistance Coordinators. Input is requested from District Attorney, Judges, and Law Enforcement.

LIVE HEARING – Applicant interviewed. Victim testimony or Victim Impact Statement is considered. District Attorney, Judges, and Law Enforcement participate in the hearing.

OUTCOME – Application is denied or a recommendation is made to the Governor.


Governor's Actions

The chart below shows what recommendations Governor Edwards approved for clemency. Pardons restore an applicant's rights after they have completed the sentence imposed by the court. Commutations alter an incarcerated applicant's sentence and provides parole eligibility. The relief in sentence length received by incarcerated applicants is reflected in the year ranges.



Parole Process

The Committee on Parole makes a variety of critical decisions concerning the timing of release, conditions to be imposed, and supervision strategies. Determination of release suitability of eligible offenders is made through decisions that promote fairness, objectivity, and public safety and are responsive to the concerns of victims, members of the community, and other entities within the criminal justice system.




ELIGIBILITY – DPS&C submit statutorily eligible offenders to be considered for parole. This is for an offender's initial hearing only.

ADMINISTRATIVE REVIEW – Subsequent hearings must be requested by the offender. This request is granted (hearing scheduled) or denied.




INVESTIGATION – Investigation is ordered. Victims are interviewed by Victim Assistance Coordinators. Input is requested from District Attorney, Judges, and Law Enforcement.

LIVE HEARING – Offender interviewed. Victim testimony or Victim Impact Statement is considered. District Attorney, Judges, and Law Enforcement participate in the hearing.



OUTCOME – Parole denied or Parole Granted with Standard Conditions and may include additional conditions which can be completed prior to or after release.



Parole Numbers


Parole Hearings chart show the number of hearings conducted by year and paroles granted. The increase in parole hearings in 2018 & 2019 is a result of the 2017 Criminal Justice Reform package of legislation. The decrease in hearings in 2022 is due to additional Clemency hearings being conducted. In 2023 we were forced to cancel 53 hearings in response to litigation against the Board.

Conditional Releases chart shows the number of offenders that were required to complete programming prior release on parole. The decrease in 2020 are due to Covid-19 and DPS&C shutting down transfers. We receive updates annually on Certified Treatment and Rehabilitation Programs offered by the DPS&C. These updates help the Board to understand appropriate offender placement based on the needs of the offender.






Discretion & Public Safety

Discretionary release is based upon the consideration of unique factors and variables of each offender's case. The Committee determines release suitability of eligible offenders through decisions that promote public safety and are responsive to the concerns of victims, other stakeholder within the law enforcement and other members of the community. The Committee's recidivism rates are a direct result of the use of evidence based practices, the in-depth investigation conducted and the eligibility requirements outlined in LARS 15:574.4 .

5 Year Parole Release Recidivism shows the comparative recidivism rates between parole releases and regular prison releases. The results are significantly better for the parole population.






Parole By Race and Sex



Parole vs. Good Time Parole Supervision (GTPS)




GTPS By Race and Sex





Average Number of Offenders by Supervision Types



Victims of Crime Act




The Victims of Crime Act provides federal support to state and local programs that assist victims of crime. In FY 23 the Louisiana Commission on Law Enforcement Administration of Criminal Justice (LCLE) administers the Louisiana VOCA funding allocation and provides funds to the Board to provide services directly to victims and survivors

navigating the post-conviction criminal justice system. These funds were utilized throughout 2023 by the Louisiana Victim Outreach Program (LAVO) and our Crime Victims Services Bureau (CVSB). We were able to deliver counseling referrals, advocacy, and survivor-focused events to community members statewide in person and via Zoom. Our team continued to work diligently to provide support and resources to victims and survivors of crime. LAVO has recently updated their branding in order to better align with their key objectives and services. As a result, our message is now more welcoming and relatable, and it emphasizes their mission. This update has made our resource guides more accessible and user-friendly. Additionally, we've added a new feature - an interactive map that allows individuals to locate services in their vicinity. This new feature can be particularly helpful for those who may not be familiar with the area or are in urgent need of assistance.

As we transition into 2024, LAVO continues to focus on supporting victims and survivors and creating a supportive space for service providers across the state to collaborate and address professional wellness within the victim services community.



Victim Assistance Coordinator

Since its implementation in April 2020, the Victim Assistance Program continues to secure victim impact statements for upcoming pardon and parole hearings in a trauma informed manner. The nine Victims Assistance Coordinators and Program Administrator are stationed around the state and work with each Probation and Parole District to secure comments on all upcoming hearings related to a sex or violent offense. These individuals were integral to our office maintaining open lines of communication with District Attorneys around the state and played a huge role in the planning and executions of our outreach events in New Orleans, Lafayette and Alexandria. We have continued to identify and participate in various trainings with the goal of improving our trauma-informed approach to addressing the needs victims. In calendar year 2023 we provided services to 2,139 victims and survivors, up 5% from 2022 and up 24% from 2021. This chart identifies the seven main victimization types the victims and survivors we provided services to in 2023.



Outreach Events




In January 2023, LAVO organized its first outreach event of the year in New Orleans. The *Krewe of Community Connections* event was held in collaboration with the Voices of Victims Support Group, and aimed to connect multiple social service agencies in Greater New Orleans with victims and survivors. The event was attended by several local agencies and service providers such as Crime Survivors NOLA, Jefferson Parish Human Services Authority, Jefferson Parish District Attorney, Committee for A Better New Orleans, Metro Centers for Community Advocacy, National Alliance on Mental Illness New Orleans, Orleans Parish District Attorney, St. Bernard Parish District Attorney Perry M. Nicosia (pictured left), Orleans Parish Sheriff's Office, and River Oaks Hospital. The main objective of the event was to facilitate connections between service providers, individuals in need, and other organizations for future collaborations.



Victim & Survivor Services Continued

During National Crime Victims' Rights Week, LAVO, CVSB and the Rapides District Attorney Phillip Terrell's Office hosted *One Community, One Voice*, an outreach and awareness event to inform community members in Alexandria of the support services available in their communities. Various agencies and service providers local to Alexandria participated. Among them were Sexual Trauma Awareness and Response (STAR), United Way of Central Louisiana, Faith House Domestic Violence Crisis Center, Family Justice Center of Central Louisiana, Mothers Against Drunk Driving (MADD), Louisiana Healthcare Connections, Louisiana State Police Troop E, Probation and Parole, Louisiana Office of Public Health, ViaLink, Alexandria Police, and Central Louisiana Health Education Center. This event allowed service providers to connect with individuals in the community needing their services and with other organizations to further future collaboration efforts.

In June, LAVO produced *Innovating Justice: Strengthening Victim Support Networks through Collaboration & Progress*, a new training event for service providers and individuals working within the criminal justice system across Louisiana. During a day of exciting presentations, attendees heard from the Louisiana Protective Order Registry, Hearts of Hope, Tulane University, and our keynote speaker, Obbie West an international spoken word artist known as an avid sexual abuse prevention advocate. Topics covered surrounded investigations of sexual abuse for adults and children, a crash course on the Protective Order Registry, and the benefits and risks of Title IX to Sex Crimes Investigations. This event was an opportunity for professionals to further their development and a time to create new and strengthen existing relationships to promote inter-agency support.



Trauma-Informed Tuesday

LAVO continued providing training opportunities for service providers nationwide through our Trauma-Informed Tuesday monthly training seminars. We hosted eight live training webinars by Myra Strand, of Strand Squared Solutions, on several vital topics addressing the numerous aspects individuals working within the criminal justice system face. These trainings were able to educate our colleagues on professional wellness and the importance of taking care of ourselves to better care for the people we serve while addressing the delicate areas of our jobs working with victims and survivors. Topics included the Impact of Pornography, Looking for Trauma-Informed Therapy that Works, Self-Regulation and Holistic Care, An Intersectional Understanding of Historical Trauma, Clergy Sexual Abuse Cases, and Neurodiversity and Incarceration. To finish the year, Mrs. Strand visited our offices to provide training to Board and DPS&C staff on maintaining proper wellness and self-regulation for individuals working within the criminal justice system.



Victim & Survivor Services Continued

National Organization of Victim Assistance

In August, Jolie Duarte and Francis Abbott (pictured right) provided training at the National Organization of Victim Assistance's 49th Annual Training Conference in New Orleans. Having been selected from 100s of other applicants, their training, *Providing Victim Services in the Post-Conviction Process*, touched on the growth and progression of LAVO and how to implement a similar organization elsewhere.



Internship Program

LAVO was able to expand its staff with the implementation of an intern program with the Louisiana State University Sociology Department. From January through May, student interns Rylee Haggard and Paige Grow (pictured left) supported our program while learning more about the inner workings of the pardon and parole process. Upon graduation Ms. Haggard started to work full time with the LBPCP.



Victim Impact Listen and Learn Curriculum

The *Victim Impact: Listen and Learn* Curriculum is an approved as a certified treatment rehabilitation program within the Department wherein offenders who are eligible for good time credits may earn 90 days. During 2023

CVSB Director Gail Guerin conducted statewide trainings for transition specialists, mental health staff, chaplaincy staff and other corrections professionals. The course continues to grow momentum and interest among corrections professionals and the incarcerated population.



The Accountability Letter Program

The Accountability Letter Program is taught by Transition Specialists to offenders housed in state institutions and local jails. An accountability letter, is a letter written by an offender to the victim(s) of the crime(s) for which the offender has been sentenced, accepting responsibility for the crime, acknowledging the harm caused to the victim, and expressing regret for that harm. CVSB received a total of 159 accountability letters during the 2023 year.



Victim Offender Dialogue (VOD)

The Victim Offender Dialogue Program (VOD) provides victims and survivors the opportunity to give voice to their trauma regarding the crime committed against themselves or their loved ones. VOD facilitators are volunteers from a variety of professional backgrounds. The VOD Program held a total of seven trainings combined with case reviews, during 2023. The trainers included Ray Nash a 40-year law enforcement professional who is now the founder of the Police Dynamics Institute. The training provided to the facilitators focused on Inductive Interviewing Skills, a non-linear, non-coercive approach to forensic interviewing for the law enforcement/public safety and mental health professions. Additionally, Stephanie Belgard, a survivor of homicide, presented on the criminal justice system from a victim perspective. Dr. Danna Andrus provided the team with team building and skills.



Long time VOD Facilitator Catalene Theriot was recognized for her work as a victim advocate when she was inducted to the Louisiana Justice Hall of Fame. She started as a VAC in the 16th Judicial District in 2003 and in 2005 became the second trained VOD Facilitator in the State of Louisiana. She later went on to start Voices of Innocent Citizens Empowered (VOICE). This group provides support to victims and survivors of crime and actively lobbies the legislature to ensure the rights of victims are protected.

I have the privilege to manage restorative programs Victim Offender Dialogue, Accountability Letter Program and the Victim Speaker Program to underserved victims of crime.
